- The State shall ensure completion of Delegation of Administrative and Financial Powers 5. during the current financial year and funding of Integrated Disease Surveillance Programmes will be based on clear delegation as per earlier directions.

Surveillance Project and shall submit within six months of closing of financial year Statutory Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs / SOEs and Statement of Fund Position showing unspent balances, funds released as advances, interest earned on unspent balance.
