8. The fund to the Uttarakhand State Health Society has been released from Budget Estimate (Domestic Budget Component) for the financial year 2012-13 of MOH&FW, Government of India. Releases made under this Sanction Order are only in respect of Programmes/ Schemes/ activities to institutions or organisations set up as Autonomous organizations under a specific statute or as a Society registered under the Societies Registration Act, 1860 or Indian Trusts Act, 1882 or other statutes as per Rule 206 (a) of GFR 2005, for which:
 - A. Unspent balance for the previous year 2011-12 has been adjusted.
 - B. UCs/FMRs/SOEs up to 31st March 2012 have been received from the State
 - C. UC is not pending for the year 2011-12 from Uttarakhand State.
(Applicable only while releasing the second instalment and statutory audit)
9. The accounts of the grantee institutions/organizations shall be open to inspection by the sanctioning authority and audit both by the C & AG of India under the provisions of CAG (DPC) Act, 1971 and internal audit wing of the office of CCA, MOH & FW.
10. The expenditure will be met out of the approved Budget Estimates under Demand No.46 – Department of Health & Family Welfare, Major Head “2210” Medical and Public Health 06800. Other Expenditure (Minor Head) 27- Integrated Disease Surveillance Project 2704 Grants to States Societies for various Components (GC) 270431 – Grant –in-Aid-General to State Societies during the current financial year, 2012-13 (Plan).
