1. Authorisation to incur expenditure will be subject to the guidelines, terms and conditions laid down in the Administrative Approval of the State PIP for 2013-14. Records of Proceedings of the NPCV. A certificate to this effect should accompany the Utilization Certificates in due course.
2. The Nature of the Grants-in-Aid is being released is recurring and the objective for which it is being released is as below:
 The project development of NCDs is to improve the information available to the Government Health Services and Private Health Care providers on a set of high-priority diseases and risk factors, with a view to improve on the ground responses to such diseases and risk factors.
3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MOU & FW, Government of India.
4. The State shall ensure that 25% of its share based on release of funds by Government of India is credited to the designated Public Sector Account within one month of the release order.
5. The State shall ensure compliance with delegation of Administrative and Financial Powers during the current financial year and ending of Integrated Disease Surveillance Programme. All on basis on the delegations per earlier directions.
6. The State shall follow all the financial management systems under Integrated Disease Surveillance Project and shall submit within six months of closing of financial year statutory Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, MRS, SOI and Statement of Income & Expenditure showing unspent balances, funds released as advances, interest earned on capital advance.
